BOHAM brought its first-ever children's choir of 18 Ugandan children to the US in 2018, touring seven states. These 18 kids and 4 chaperones stayed for 6 months and shared their hope for a bigger and brighter future through song, dance, and the playing of musical instruments. The children performed at churches to spread the Gospel and raise awareness and support for their communities back home. The focus was to grow our base of support for Ugandan children in several communities through BOHAM's sponsorship program. As a result, the majority of the children in our program were sponsored; many had been waiting more than 3 years. The choir tour grew sponsorship from 70 children to more than 125 children, with multiple sponsorships per child. Because of that, 125 children started school, more than 100 children and families started the microenterprise project to earn additional income from their homes, and the Bible Club grew in attendance with several children coming to know the Lord! In addition, throughout the tour, children stayed with different host families as part of a cultural and educational exchange. It was our hope to not only impact families with the love of Jesus Christ, but to help BOHAM's children become future change agents for their society and help their communities back home be lifted out of poverty.

Child sponsorship fees cover school supplies, scholastics, uniforms, meals, medical care, microenterprise supplies, and training and other related expenses. The heart of our ministry is to provide opportunities for children. We believe teaching children entrepreneurial skills will put them on a path toward success. We aim to do that through the microenterprise component of sponsorship. In 2018, more than 100 children and families started the microenterprise project to earn additional income!

The microenterprise project through our sponsorship program has been the rearing of

chickens and selling of eggs. The entire family learns important business concepts such as budgeting and saving for the future. By caring for chickens, children and their families experience better nutrition themselves; by selling eggs, they earn a small income, which makes for a much brighter future for both the families and their children. Families have also reported experiencing a new sense of ownership and pride in their small business and empowerment over their lives!

Support of the Uganda office has enabled the direct tangible support of children and their families. This expense covers community development, discipleship, and related supplies. The majority of our Ugandan staff are former sponsored children who personally experienced the life-transforming effects of being assisted out of poverty. They understand firsthand the needs of the communities we serve and are passionate about finding solutions to poverty. Each day, the staff interacts with families and provides support in the form of social work. They provide regular home visits to check on families and offer tangible, emotional, and spiritual support. Community development trainings work to teach and enhance skills for families in our program, including training on: parenting, hygiene/sanitation, family planning, job skills, etc. In addition, we offer a Women's Sewing Project Initiative. Mothers who join the project learn valuable skills and gain the confidence to be entrepreneurs in their communities.

Child gifts provided by US-based donors and wired directly to Uganda purchase food and critical supplies for sponsored children and their families. In fact, many families lack the basic, everyday necessities to fully function and be lifted out of poverty. Providing such basics as a mattress, food package, hygiene kit, or solar panel is a tangible and substantial way to help families in need. A staggering 80%

of families in the BOHAM program lack proper bedding, and 60% of our sponsored children often go without food during school breaks. Thankfully, child gifts are one way that sponsors and ministry partners can give above and beyond to sponsored children in the program! In 2018, 105 children were impacted by child gifts. 547 gifts were given totally \$34,652.

Special projects are designated toward major needs in the community, including medical operations, housing improvements, and job skills training.

Direct United States staff support of program services like the choir tour enabled the oversight and management of tour logistics including concert scheduling, housing logistics, travel arrangements, etc. These supporting services enabled the tour to run smoothly while growing child sponsorship and awareness of the BOHAM organization across churches and local communities in the United States.

Support of the Choir in Training covers the housing & training costs associated with the children who are expected to tour the United States for outreach and to promote the organization.

Mission trips through BOHAM provide a new perspective about the work God is doing locally in other parts of the world such as Wakiso and Mityana, Uganda. Our desire is for mission team members to become more aware of different cultures, to serve alongside others, and to return home transformed. It is our hope that individuals will not only impact communities and families in Uganda, but grow closer to Jesus through these acts of service and come to know Him more deeply. When teams arrive, we provide activities whereby they can work with the BOHAM Uganda staff to meet

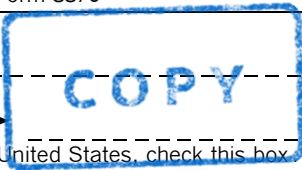
